The *added traffic*, *noise*, *and smell* will affect the lives of everyone in Ingersoll and Beachville, an area in the heart of beautiful Oxford County prime farmland. Why should they have to deal with an industrial level dump site because Toronto just wants their garbage to go away. We are not away - we live here.

I believe there is a bill under consideration giving municipalities a say in where dumps and gravel pits can be located. I live a neighbouring community, and I say "NO" to the dump.

You have seen the opinions of lots of people regarding a dump in Zorra. You might not have seen this one:

When the plan began 6 years ago, Zorra sought legal counsel, committees where set up i.e. Joint Municipal Coordinating Committee, Community Liaison Committee and funding was secured for peer review.

Going forward as a council we need to build on steps taken, and be aware of changing legislation and the opportunities that this may provide us.

I would call on the public to continue with the research, the rallies, the public posts, ensure that the results are passed on to Municipal councillors, County Councillors, Ernie Hardeman ...
